# QUARTUS and Sham - Relyens group sign an off-plan sale for a 9,800 m<sup>2</sup> building in the ILO23 development in Clermont-Ferrand

QUARTUS has announced the off-plan sale of an office building on behalf of Sham - Relyens group. The building forms part of ILO23, a 37,600 m<sup>2</sup> mixed-use property development designed by ANMA, which entered the construction phase in September.

The 8-storey building, which is fully leased to a large-scale operator, offers 9,800 m<sup>2</sup> of office space and a car park with 329 spaces and green roof (4th storey). The development has been subject to an environmental certification procedure: its energy performance is compliant with the French RT 2012 standard, and it has been rated "excellent" under the BREEAM International New Construction 2016 certification system.
